Any Other Business

- 9.1 <u>Ash Tree</u> On the proposition of Councillor Belgrove seconded by Councillor Settle it was agreed to accept the Quotation for the remedial work to the Ash Tree in the Playing Field. Councillor Hallam to advise Arbolution Tree Services to proceed.
- 9.2 Insurance On the proposition of Councillor Settle seconded by

Councillor Belgrove a Quotation from Zurich Municipal of £457.20 for the Council's Insurance was agreed.

- 9.3 <u>Broadband</u> On the proposition of Councillor Belgrove seconded by Councillor Hallam it was agreed to contribute £186.50 towards the provision of Broadband to the Village Hall.
- 9.4 Longdown Lane/A45 Junction

Mr B Hall raised concerns over the safety at this junction following a fatal accident recently. He added that Villagers were afraid to turn into Willoughbý Village at this junction and with the increased traffic along the A45 and turning into and out of Longdown Lane towards Barby action was needed to prevent further accidents. Councillor Thomas agreed to contact the Warwickshire County Council Highways on site to discuss the problem and report back to the Parish Council.

9.5 <u>Potholes</u> – The Localities Officer of Warwickshire County Council is to be approached to look into the potholes in Moor Lane.
