Councillor Belgrove to look into treating the wood exterior on the Shelter Roof. 8.2 Conservation Issues - Council agreed to have WS Gardens carry out one last cut on the Villages verges and Playing Field due to the continued growth of the grass. 8.3 Highways - The Council has requested the Enforcement Officer of Rugby Borough Council to look into the "Change of Use" at the garage on the A45 as the Council is not aware of any formal application for Change of Use. 8.4 Neighbourhood Watch - Councillor Settle reported that two Batteries were stolen from outside Little Shaws recently.
